

NORTHWEST YOUTH ADVOCACY

Amplifying Electoral Reform in the sub-National Legislative House and the Media

In the Northwest region, youth-led advocacy continues to drive the adoption of the youth electoral reform priorities. Through the efforts of the Jesz Development Foundation (J-Dev), youth advocates engaged with key figures such as Hon. Rilwanu Sahabi Magarza, the youngest legislator in the Kebbi State House of Assembly. Magarza pledged his support, signalling his intent to push the recommendations forward within both state and federal assemblies.

Additionally, JDEV volunteers spoke at radio programs including Caliphate Radio in Sokoto, Vision FM in Katsina and Nagari FM in Kebbi. These provided platforms for youth to share their electoral reform agenda with the public. These media engagements are a critical tool in raising awareness, and ensuring that youth voices resonate across the region.

NORTHEAST SPOTLIGHT

Youth Leaders Win Support in Yobe and Bauchi

Northeast youth have been equally proactive, with the YERP-Naija team in Yobe State meeting with the Speaker of the Yobe State House of Assembly, Hon. Nasiru Hassan. He expressed gratitude for the youth's contributions and pledged to push the electoral reform recommendations within his legislative networks.

Similarly, in Bauchi, the team's visit to the Emir of Dass garnered enthusiastic support for the youth reforms. The Emir's promise to advocate for these recommendations in his advisory role to state leaders highlights the importance of traditional rulers in advancing democratic reforms.







Youth-Led Push for Electoral Reform Gains Momentum in Ogun State

The Ogun State YERP-Naija team met with Ogun State House of Assembly Minority Leader, Hon. Lookman Adeleye. Key issues discussed included mandatory electronic transmission of results, year-round voter registration, and transferring INEC appointment powers to a non-partisan body. "If the youth are not part of the system, they cannot drive the changes they desire," said Adeleye, affirming his commitment to supporting youth involvement in electoral reforms and calling for increased youth voices in politics.





ROYAL ENDORSEMENT FOR ELECTORAL REFORM

Obas in Ekiti Rally Behind Youth Movement

Abimbola Aladejare–Salako, Executive Director of NIGAWD, led a YERP–Naija advocacy meeting with 73 traditional rulers in Ekiti State. The leaders pledged their support for youth–led reforms. The Olojudo of Ido–Ekiti remarked, "We, as traditional leaders, must ensure that the youth's voices are heard and their recommendations championed." The meeting emphasized the importance of the electoral reform recommendations being presented to the National Assembly, with the Chairman, Council of Obas, and the Olojudo of Ido–Ekiti, committing to sign a pledge card on behalf of all the kings to support this initiative.



Youth Voices Takes Centre Stage in Ondo State



YERP-Naija, under the leadership of NIGAWD, met with Ondo State INEC Resident Electoral Commissioner (REC), Hon. Oluwatoyin Babalola. The focus was on increasing youth voter participation for the forthcoming elections advocating the youth agenda for electoral reform. Babalola emphasized, "Youth engagement is crucial to ensuring Nigeria's electoral integrity." Babalola praised the movement's role in mobilizing youth voters and expressed commitment to considering YERP Naija's administrative recommendations to improve the electoral process, including extending PVC collection centres and enhancing youth voter participation. "These recommendations are critical to ensuring a free, fair, and credible election," she emphasized, pledging to implement them in preparation for the elections.

Edo State GOTV Campaign

In the run-up to the Edo State governorship elections, YERP-Naija volunteers launched a dynamic Get Out the Vote (GOTV) campaign across 18 Local Government Areas. By engaging directly with youth in public spaces such as markets, motor parks, and churches, the campaign has been instrumental in mobilizing a new generation of voters, urging them to exercise their democratic rights. This grassroots mobilization is critical to ensuring robust voter turnout, especially among youth, a demographic that has often been disengaged from electoral processes.



Strategic Engagement with Edo State Security Agencies and Media



Ahead of the Edo elections, the WTF Team made crucial advocacy visits to the Edo State Commissioner of Police, media organizations, and civil society groups. The purpose was to emphasize the importance of security, transparency, and administrative reform in the electoral process. These advocacy efforts culminated in a press conference, where the team unveiled five priority recommendations concerning electoral security, the deployment of INEC officials, and real-time results transmission. The press conference, attended by 10 media organizations, ensured widespread dissemination of these recommendations, amplifying youth perspectives in the lead-up to the elections.







South-East MobilizationAdvocacy at the Highest Levels

senators, signalling a potentially significant shift in the legislative discourse surrounding electoral reform.



The South-East region has been particularly active, with advocacy visits to key political and traditional leaders. The YERP-Naija youth volunteers met with Senator Victor Umeh, who voiced strong support for the youth reform agenda, particularly the establishment of an Electoral Offenses Commission and the adoption of continuous voter registration. Umeh pledged to ensure that these recommendations would reach all 109





Similarly, the President of Ohaneze Ndigbo Worldwide, Obi Chukwuemekalum Udodeme, met with youth leaders to discuss how traditional institutions can amplify these electoral reform demands. He vowed to use his platform to promote the youth agenda, including featuring the reform priorities on Anambra Broadcasting Station (ABS), highlighting the deepening connection between youth and traditional power structures in advocating for democratic change.

GAINING RELIGIOUS ENDORSEMENT

Cardinal John Onaiyekan's Support for Youth Electoral Reform

To bolster the YERP-Naija advocacy efforts, KDI sought the moral support of Cardinal John Onaiyekan, Archbishop Emeritus of Abuja. Cardinal Onaiyekan's influence as a respected moral authority in Nigeria

offers the YERP-Naija project an invaluable ally. His commitment to supporting these reforms speaks to the universal importance of youth participation in governance and electoral processes, providing a critical boost to the project's outreach to influential religious communities.

SPOTLIGHT

Concluding Post-Election Disputes Before

Inauguration—A Pathway to Stability and Fairness

One of the critical priorities in the youth electoral reform agenda is ensuring that all post-election disputes are resolved before the swearing-in of elected officials. This recommendation addresses a significant gap in the current electoral system, which allows candidates with unresolved cases in court to assume office, potentially giving them undue influence over the judicial process.

Key Constitutional Amendments:

Pre-Election Cases:

- Section 285(10): Reduce the timeframe for hearing and determining pre-election matters from 180 days to 60 days.
- Section 285(12): Shorten the appeal window for pre-election matters from 60 days to 30 days at the Appeal Court.

Post-Election Cases:

- New Addition to Section 232(1): Grant the Supreme Court original and final jurisdiction in presidential election disputes, removing appellate delays.
- Section 239(1): Empower the Court of Appeal with original jurisdiction to hear governorship election disputes.
- Section 285(2): Limit eligibility for filing post-election petitions to candidates/parties with at least 20% of the total votes.
- ♦ Timeline Reduction: Shorten the days for hearing post-election cases to 50 days, enhancing efficiency in the process.

Rationale: Currently, the prolonged litigation timeline undermines electoral integrity by allowing candidates with ongoing court cases to assume office. This creates an uneven playing field where incumbents can leverage the powers of their new office to influence the outcome of their election cases. By ensuring all cases are concluded before inauguration, this reform will:

- **Foster fairness:** Elected officials won't be sworn in under a cloud of legal uncertainty, creating a level playing field for all parties.
- **Reduce pressure on the judiciary:** Judges will have a fixed timeline to resolve disputes without the complexity of dealing with sitting officeholders.
- **Enhance confidence in the electoral process:** Voters will trust the outcomes, knowing that their votes have not been overturned by undue advantages from already installed officials.

This recommendation ties directly into broader amendments within Section 139(1) of the 2022 Electoral Act and should be passed along to the Senate Committee on Electoral Matters for further action.

By addressing these legislative gaps, Nigeria's electoral system will become more transparent and accountable, ensuring that elected officials take office with legitimacy and without the shadow of unresolved legal disputes.
